## **ABSTRACT**

The Belt and Road Initiative (BRI), launched in 2013, amounts to trillions of dollars in expected infrastructure spending over 60 countries. Marked as President Xi Jinping's keynote foreign policy vision, it is going to be a defining aspect of China in the next decades. China's investment into foreign economies is surging and evolving in scope. Although the sustainable development and global connectivity vision promoted by the initiative are warmly welcomed in a number of industries and business communities, there is an urgent need to differentiate commercial goals from geopolitical ones. Access to digital and critical infrastructure create concerns for countries along the way. For countries where this investment is taking place, there is an important balance to be struck between economic interests and national security. For Chinese firms going out, there is the question of balancing these realities against their own goals and national directives at home and abroad. Furthermore, the BRI is not immune to a number of important risks that in many instances are new to Chinese companies operating abroad. In fact, they acknowledge that the risks associated with investments in emerging economies carry a failure rate due to intertwined factors as economic crises, conflict, civil unrest, assets nationalization and currency devaluation. However, due to their public nature and commercial capacity, they tend to blur the lines between commercial and political factors and, consequently, to rely too optimistically on Beijing's support in case of a crisis.
